

QUOTIFY AFFILIATE PROGRAM AGREEMENT

Effective Date: July 30, 2026

This Affiliate Program Agreement ("**Agreement**") is entered into by and between **SuperFlo Technology Solutions, LLC**, an Ohio limited liability company ("**SuperFlo**," "**we**," "**our**," or "**us**"), and the individual or entity enrolling in the Quotify Affiliate Program ("**Affiliate**," "**you**," or "**your**").

By clicking "**I Agree**," enrolling in, accessing, or participating in the Quotify Affiliate Program, you acknowledge that you have read, understood, and agree to be legally bound by this Agreement.

1. Program Overview

The Quotify Affiliate Program ("**Program**") permits approved Affiliates to promote Quotify through approved websites, applications, or other digital properties by embedding Quotify-powered vehicle shipping quote tools.

Quotify is a technology platform owned and operated by SuperFlo Technology Solutions, LLC. Transportation services are arranged and performed exclusively by independent, licensed auto transport brokers and motor carriers.

Nothing contained in this Agreement creates or implies a transportation contract between SuperFlo and any customer.

2. Eligibility

To participate in the Program, Affiliate represents and warrants that:

- Affiliate is at least eighteen (18) years of age.
- Affiliate has the legal authority to enter into this Agreement.
- Affiliate owns or is authorized to operate each website or digital property where Quotify is displayed.
- Affiliate will comply with all applicable federal, state, and local laws and regulations.

SuperFlo reserves the right to approve, reject, suspend, or terminate any Affiliate application in its sole discretion.

3. Affiliate Responsibilities

Affiliate agrees to:

- display Quotify only on approved websites or digital properties;
- accurately represent Quotify and its services;
- maintain current and accurate account information;
- comply with all applicable advertising, privacy, and consumer protection laws;
- promptly remove Quotify branding or marketing materials upon request by SuperFlo.

Affiliate shall not make promises or guarantees regarding pricing, pickup dates, delivery dates, carrier availability, shipment timing, or transportation outcomes.

4. Commission Eligibility

Affiliate commissions are earned only after **all** of the following conditions have been satisfied:

1. The customer submitted a quote request through Affiliate's Quotify integration.
2. The customer booked transportation through the Quotify platform.
3. The vehicle shipment was completed.
4. Payment for the shipment was successfully collected by the participating broker.
5. The transaction was not cancelled, refunded, charged back, disputed, duplicated, fraudulent, or otherwise determined by SuperFlo to be ineligible.

No commission is earned until all eligibility requirements have been satisfied.

SuperFlo shall have the exclusive authority to determine commission eligibility, attribution, payment amounts, and commission adjustments. Such determinations shall be final except where prohibited by applicable law.

5. Commission Payments

Commission rates, minimum payout thresholds, payment schedules, and approved payment methods shall be established by SuperFlo and published within the Quotify Affiliate Portal or otherwise communicated to Affiliates.

SuperFlo reserves the right to withhold, deny, offset, or reverse commissions resulting from:

- fraudulent activity;
- invalid or duplicate referrals;
- cancelled shipments;
- chargebacks;

- self-generated transactions;
 - abuse of the Program;
 - violations of this Agreement.

6. Referral Attribution

Referral attribution shall be determined exclusively by SuperFlo using the attribution methodology in effect at the time a qualifying quote request is submitted.

Where multiple referral sources exist, SuperFlo shall determine commission eligibility in its sole discretion.

7. Customer Relationship

Affiliate acknowledges that customers submitting quote requests through Quotify become customers of the participating licensed auto transport broker.

Affiliate acquires no ownership rights in customer information, customer relationships, or future business generated through the Program.

Affiliate shall not:

- solicit Quotify customers for competing transportation services;
 - represent itself as the transportation provider;
 - interfere with customer communications after a quote request has been submitted.

8. Customer Support

Affiliate acknowledges that all shipment-related questions, concerns, disputes, claims, and communications must be directed to the customer's contracted auto transport broker or shipping company.

Affiliate shall not:

- negotiate shipment pricing;
- provide shipment status updates on behalf of a broker;
- resolve transportation disputes;
- make commitments regarding transportation services.

Questions relating to the Quotify platform may be directed to SuperFlo.

9. Code of Conduct

Affiliate agrees to conduct business honestly, professionally, and ethically.

Affiliate shall not:

- make false or misleading statements;
- misrepresent Quotify or SuperFlo;
- submit fraudulent quote requests;
- submit fabricated customer information;
- generate artificial traffic;
- use bots or automated submissions;
- engage in click fraud;
- encourage customers to bypass participating brokers;
- misuse customer information;
- engage in deceptive, unethical, or unlawful marketing practices.

Violation of this section may result in immediate termination of participation and forfeiture of unpaid commissions.

10. Advertising Compliance

Affiliate shall comply with all applicable advertising and consumer protection laws, including the Federal Trade Commission ("FTC") Endorsement Guides and any successor regulations.

Where required by law, Affiliate shall clearly disclose its affiliate relationship with Quotify.

11. Prohibited Marketing Practices

Without prior written consent from SuperFlo, Affiliate shall not:

- bid on or purchase search advertisements using the trademarks "Quotify," "Transport Auto Quoter," "TAQ," "ProABD," or confusingly similar variations;
 - send unsolicited commercial email or spam;
 - distribute malware, spyware, or deceptive software;
 - promote Quotify through unlawful, defamatory, hateful, obscene, or adult-oriented content;
 - alter or modify Quotify widgets, APIs, scripts, or software.

12. Intellectual Property

All trademarks, logos, trade names, copyrights, software, APIs, widgets, documentation, graphics, and other intellectual property associated with Quotify remain the exclusive property of SuperFlo Technology Solutions, LLC.

Affiliate is granted a limited, non-exclusive, revocable, non-transferable license to use approved Quotify marketing materials solely for participation in the Program.

No ownership rights are transferred under this Agreement.

13. Confidentiality

Affiliate shall not disclose or use any confidential or proprietary information obtained through participation in the Program except as necessary to perform under this Agreement.

Confidential information includes, without limitation:

- commission structures;
- pricing methodologies;
- software functionality;
- APIs;
- customer information;
- technical documentation;
- internal business practices;
- marketing strategies.

This obligation survives termination of this Agreement.

14. Privacy & Customer Data

Affiliate shall comply with all applicable privacy laws regarding the collection, storage, and transmission of customer information.

Customer information collected through Quotify shall be used solely for purposes authorized by SuperFlo and applicable law.

Affiliate shall not sell, transfer, disclose, or otherwise use customer information for unrelated marketing or commercial purposes without the customer's express consent and where otherwise permitted by law.

Affiliate acknowledges that SuperFlo's collection and processing of customer information is governed by its Privacy Policy, as amended from time to time.

15. Independent Contractor

Affiliate is an independent contractor.

Nothing contained in this Agreement creates any employment relationship, partnership, joint venture, agency, franchise, fiduciary relationship, or similar relationship between Affiliate and SuperFlo.

16. Taxes

Affiliate is solely responsible for reporting and paying all taxes arising from commissions earned through the Program.

SuperFlo may require submission of IRS Form W-9, Form W-8BEN, or other applicable tax documentation prior to issuing payments.

17. No Transportation Services

SuperFlo, Quotify, Transport Auto Quoter (TAQ), and ProABD provide software and technology services only.

Neither SuperFlo nor its software products:

- transport vehicles;
- operate as a motor carrier;
- employ drivers;
- dispatch carriers;
- supervise shipments;
- guarantee transportation services.

Transportation services are provided exclusively by independent licensed brokers and motor carriers.

18. Limitation of Liability

To the fullest extent permitted by applicable law, **SuperFlo Technology Solutions, LLC, Quotify, Transport Auto Quoter (TAQ), ProABD, and each of their respective owners, officers, directors, employees, contractors, agents, successors, and affiliates shall not be liable for any direct, indirect, incidental, consequential, special, punitive, or exemplary damages arising from or relating to the shipment or transportation of any vehicle**, including but not limited to:

- vehicle damage;

- transportation delays;
- missed pickup or delivery dates;
- cargo claims;
- insurance disputes;
- broker or carrier negligence;
- theft;
- accidents;
- weather-related events;
- mechanical failures;
- acts or omissions of third parties.

All shipment-related claims shall be directed exclusively to the customer's contracted broker or motor carrier.

19. Indemnification

Affiliate agrees to defend, indemnify, and hold harmless SuperFlo Technology Solutions, LLC, Quotify, Transport Auto Quoter (TAQ), ProABD, and their officers, directors, employees, contractors, successors, and affiliates from and against all claims, damages, liabilities, judgments, costs, expenses, and reasonable attorneys' fees arising from:

- Affiliate's breach of this Agreement;
 - Affiliate's website or marketing activities;
 - Affiliate's negligence or misconduct;
 - violations of applicable law.

20. Audit Rights

SuperFlo reserves the right to audit Affiliate traffic, referral activity, commission claims, websites, advertising practices, and related records to verify compliance with this Agreement.

Affiliate agrees to reasonably cooperate with any such audit.

21. Suspension and Termination

SuperFlo reserves the right, in its sole discretion, to suspend or terminate Affiliate participation immediately upon determining that Affiliate has:

- violated this Agreement;
- engaged in fraudulent activity;
- generated invalid referrals;

- damaged the reputation of SuperFlo or Quotify;
- engaged in deceptive or unlawful marketing practices.

Termination shall not limit any legal or equitable remedies available to SuperFlo.

22. Reservation of Rights

SuperFlo reserves all rights not expressly granted under this Agreement.

23. Modifications

SuperFlo reserves the right to amend this Agreement. Material amendments shall become effective upon publication within the Quotify Affiliate Portal or upon other reasonable notice to Affiliates. Continued participation in the Program after the effective date of any amendment constitutes acceptance of the revised Agreement.

24. Electronic Acceptance

Affiliate acknowledges and agrees that selecting the "**I Agree**" button, checking an acceptance box, electronically signing, or otherwise enrolling in the Program constitutes Affiliate's legally binding electronic signature and acceptance of this Agreement pursuant to the **Electronic Signatures in Global and National Commerce Act (15 U.S.C. §7001 et seq.) ("E-SIGN Act")**, and any applicable state electronic transaction laws.

Affiliate agrees that this electronic acceptance has the same legal effect as a handwritten signature.

25. Copyright & DMCA Compliance

Affiliate shall respect all intellectual property rights associated with Quotify and third-party content.

If SuperFlo receives a valid copyright infringement notice relating to Affiliate's use of Quotify materials, SuperFlo reserves the right to immediately suspend or terminate Affiliate participation pending investigation.

26. Governing Law and Venue

This Agreement shall be governed by and construed in accordance with the laws of the State of Ohio, without regard to its conflict of law principles.

The parties agree that any legal action arising out of or relating to this Agreement shall be brought exclusively in the state or federal courts located in Hamilton County, Ohio, and each party irrevocably consents to the jurisdiction and venue of such courts.

27. Force Majeure

SuperFlo shall not be liable for any delay or failure to perform resulting from causes beyond its reasonable control, including acts of God, natural disasters, governmental actions, labor disputes, internet outages, cyberattacks, utility failures, or failures of third-party providers.

28. Severability

If any provision of this Agreement is determined to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

29. Waiver

The failure of SuperFlo to enforce any provision of this Agreement shall not constitute a waiver of that provision or any other provision.

30. Assignment

Affiliate may not assign or transfer this Agreement or any rights arising under it without the prior written consent of SuperFlo.

SuperFlo may assign this Agreement without restriction.

31. Entire Agreement

This Agreement constitutes the complete and exclusive agreement between the parties concerning the Quotify Affiliate Program and supersedes all prior or contemporaneous agreements, discussions, negotiations, representations, or understandings relating to the Program.
